BW2 POOL RENTAL AGREEMENT

Terms & Conditions

- 1. Pool rentals are subject to Lifeguard availability.
- 2. The person who signs this Pool Rental Agreement (herein referred to as "the renter") must be a member in good standing of the Beechwood West #2 Homes Association Inc (BW2)
- 3. A fee of \$50 (1hr), \$75 (1.5hrs) or \$100 (2hrs) must be paid by the renter no later than one week prior to the event.
- 4. Refunds will not be provided if the event is cancelled by the renter with less than 7 days notice or if pool is required to close <u>during the event</u> due to fecal fouling, thunder, lightning, heavy rain, and the like.
- 5. Refunds will only be offered if the pool cannot be opened at the scheduled event start time due to lifeguard illness, thunder, lightning, heavy rain, and the like.
- 6. The renter must remain at the pool premise for the duration of the event.
- 7. The renter must ensure that the required number of adults are present to provide supervision during the event based on the following ratios:
 - a. adults to non-swimmers must be at least 1:2
 - b. adults to swimmers under the age of 13 who pass a facility swim test must be at least 1:5
 - c. adults to swimmers age 13-18 must be at least 1:10
- 8. The maximum number of event attendees, meaning the total number of bodies at swimming and poolside, cannot exceed 30.
- 9. Attendees may arrive at the Pool House 10 minutes prior to the event start time to change, shower, etc. but may not enter the pool area until approval is given by the lifeguards.
- 10. The renter is responsible for the conduct, behaviour and actions of event attendees.
- 11. The renter is responsible for any damage to BW2 property that results directly or indirectly from the event and/or event attendees.
- 12. Facility rules must be adhered to. Lifeguards have the right to ask individuals to exit the pool and/or leave BW2 property if they deem any behavior to be dangerous, damaging and/or otherwise inappropriate.
- 13. The Beechwood West #2 Homes Association Inc. will not be held liable for any illness or injury that occurs during or as a result of the event.
- 14. All non-BW2 members must leave the BW2 pool by 12:00pm (when BW2 Free Swim begins) unless accompanied by a BW2 member and signed-in with the lifeguards.
